## TCPI Honors Martin A. Sullivan at Annual Symposium

## Sullivan is the Tenth Recipient of TCPI Pillar of Excellence Award

Sullivan, chief economist and contributing editor for Tax Analysts, will be awarded the 2019 Pillar of Excellence Award in recognition of his extraordinary contributions to the tax community and efforts to formulate tax policy. "Marty's long-tenured career, coupled with his unyielding desire to educate the tax community and the public on economic and tax policy issues, makes him well deserving of this award."

Mr. Sullivan is the tenth recipient of this award, which honors individuals who play a key role in the formulation of tax policy and the discourse which moves it forward, while serving as a prominent fixture in the tax community at large.

"Marty's contributions to the tax profession over many decades are immeasurable, and he truly exemplifies the criteria set forth by TCPI for receiving the award," said Lynda K. Walker, Esq., Executive Director and General Counsel of TCPI. "Marty, in his quest to better inform the tax community and the public on economic and tax issues that could have repercussions, has published well over 1,000 economic analyses for Tax Analysts and has also written two books on tax reform. Qualifications for the Pillar of Excellence Award include playing a key role in tax policy, impact on the tax business and national economy, participation in knowledge-sharing opportunities, and a demonstrated understanding of tax policies among professionals, executives and policymakers.

Prior to his current tenure at Tax Analysts, Mr. Sullivan taught economics at Rutgers University and served as a staff economist at the U.S. Treasury and the Congressional Joint Committee on Taxation. He graduated magna cum laude from Harvard College and received a PhD in economics from Northwestern University.
